3. PRORATION OF LICENSE FEES

Class "A" beer, "Class A" liquor, "Class B" liquor, Class "B" beer Special "Class B" Winery and "Class C" wine, when a new license is issued, a prorating of the annual license fees shall be made on the basis of the number of months or fraction thereof remaining in the licensing year which is July 1 to June 30.

Passed on the 8th day of June 2015.
